The choice of courses to which the post holder will contribute will depend on his/her experience and expertise and will be determined by the Head of Department.

The general duties and responsibilities of an LSE Fellow are as follows:

- Delivering high-quality teaching (lectures and seminars) to undergraduate and postgraduate students, face-to-face and online.
- Identifying the learning needs of students, defining appropriate learning objectives and providing ther with appropriate support.
- Preparing, marking and providing feedback on formative and summative work, including coursework, exam papers and dissertations.
- Participating in regular teaching meetings with academic and professional services staff.
- Working closely with professional services staff to ensure the smooth running of all aspects of teaching and assessment.
- Holding regular office hours.
- Acting as an academic mentor and providing pastoral care.
- Supervising mentees for their end of year dissertation, participating in dissertation workshops throughout the year and referring supervisees to expert advisors where appropriate.
- Developing a research programme and publication record e.g. through publication(s) arising from the PhD or post-doctoral research.

Flexibility

To deliver services effectively, a degree of flexibility may be required in the duties performed in order to meet the exigencies of service. Job roles may also naturally develop over time and ongoing substantial changes to a role will be discussed between line managers and their staff, with job descriptions updated as and when appropriate.
