Job Summary

Prof. Rocco Macchiavello – Professor in the Department of Management (LSE) – is seeking a motivated, independent, and highly skilled Research Assistant to support ongoing research in development, industrial organisation, international trade, and applied microeconomics for one year. The postholder will support ongoing research in development, industrial organisation, international trade, and applied microeconomics. The job will include a variety of tasks such as data analysis, writing and creating presentations, and editing research papers.

The successful candidate should have a completed Master or Bachelor's degree (or equivalent) in economics or other closely related discipline, strong quantitative and data analysis skills, and be able to manage their own areas of responsibility independently without constant direct supervision. Experience in Stata and Latex is essential and experience with MATLAB and/or R and/or Python is desirable. We are looking for someone with fluency in written and spoken English, with excellent written and verbal communication skills who can communicate effectively to different audiences, conveying complex technical information in a clear and accurate manner.

Duties and Responsibilities

- Identifying appropriate methods of investigation or analysis according to data and objectives.
- Conveying complex conceptual ideas or complex information which may be highly detailed, technical or specialist.
- Interpreting and analysing patterns or trends in data.
- Managing large scale databases.
- Conducting literature reviews.
- Assisting in the writing of reports.
- Contributing to the organisation of conferences, seminars and workshops.
- Supporting team members to reach common goals.
- Managing own research and administrative activities, with guidance.
- Demonstrating a knowledge of theory, methods and practice and demonstrating development through acquisition of relevant skills and competencies.

All of the above subject to the contractual obligations imposed by the external funding agency and with the agreement of the grant-holder, Principal Investigator and/or Head of Centre.
