#### **Job Summary:**

LSE IDEAS seeks to appoint a Dahrendorf Postdoctoral Fellow, funded by Stiftung Mercator, to carry out research on future relations between the European Union, the UK and other European states, particularly in the aftermath of the Brexit vote. You will work with the Working Group Chair, Professor Kevin Featherstone, to address an agenda that is likely to cover a range of areas: e.g. governance; foreign and security policy; migration and refugees; trade policy; and/or competition and tax policy.

The Postdoctoral Fellow will play a central role in the Dahrendorf Forum team based at LSE IDEAS, as well as collaborating closely with colleagues across LSE and at the project's partner institution, the Hertie School of Governance in Berlin.

Throughout the duration of the project, the Postdoctoral Fellow will work to progress their own research and contribute fully to the research agenda of the LSE-based Dahrendorf Working Group. S/he will also be expected to play an active role in outreach and engagement with policy-makers.

# **Duties and Responsibilities**

The successful candidate will be expected to have a PhD (see the 'Person Specification') and research experience demonstrating the capability to produce independent original research.

### Research

- Make significant progress in turning their own research into scholarly publications;
- Play an active intellectual role in the LSE-based Dahrendorf Working Group;
- Analyse and research complex ideas, concepts or theories and apply appropriate empirical methods;
- Deliver a variety of academic and policy-orientated publications (e.g. policy briefings, reports etc) both individually and co-authored - based on the work of the Dahrendorf Working Group;
- Present research at national and international conferences.

#### Communication, engagement and impact

- Synthesise research outputs and translate into accessible, policy relevant formats;
- Engage effectively with policy makers and practitioners;
- Initiate and sustain links with external bodies to foster collaboration.



### **Team working**

- Contribute towards the wider work of the Dahrendorf Forum in both London and Berlin (this will involve regular travel to Berlin and potentially other European destinations);
- Communicate regularly with the project team and help to foster an atmosphere of collaboration;
- Work closely with Hertie-based Postdoctoral Fellow affiliated to LSE Working Group;
- Participate in meetings, seminars, workshops, and the Dahrendorf Symposium;
- Play a constructive role in the life of LSE IDEAS.

## Organisation
