#### **Job Summary**

LSE100: The LSE Course, is LSE's flagship interdisciplinary course taken by all first-year undergraduates. LSE100 is recruiting creative educators with a commitment to research-led teaching to join our multi-disciplinary team. LSE100 enables students to explore ideas from across the social sciences as they tackle complex problems that cannot be fully understood from the perspective of a single discipline. Through LSE100, LSE gives all undergraduates the chance to explore fundamental social scientific questions, analysing and synthesising different disciplinary perspectives while learning to use practical, transdisciplinary analytical frameworks such as wicked problems and systems thinking.

Each week, LSE100 Fellows teach multiple 80-minute classes of 24 first-year undergraduate students from a range of disciplinary backgrounds, facilitating collaboration and peer learning. Fellows need to demonstrate a creative and flexible approach in the classroom, drawing on varied educational methods to engage students. Fellows support students in group and individual office hours and provide feedback on assessed coursework. As students will undertake a group research project, Fellows will be required to demonstrate skills in supervision, pastoral support, and problem-solving to facilitate students' learning and development as effective collaborators.

During the course of the Fellowship, Fellows will work closely with colleagues to develop classes and assessments, creating guidance materials and leading training sessions for the teaching team where appropriate. Fellows will also lead special projects for LSE100 students and staff (e.g., student events and team projects related to Equality, Diversity and Inclusion, Green Impact, and career development).

In the academic year 2021/22, LSE100 will be taught online (with in-person office hours and events where possible) and the theme will be *How can we control AI*? From autumn 2022, LSE100 will offer three thematic streams for students to choose from: 1) *How can we control AI*? 2) *How can we reverse ecological collapse*? and 3) *How can we design a fair society*? LSE100 Fellows must demonstrate interest or expertise in one or more of the streams and be able to draw on their own disciplinary background(s) and wider social scientific thinking as part of their teaching.



# **Duties and Responsibilities**

- Contribute to the scholarship and intellectual life of the School by conducting teaching and research which will enhance the School's reputation as a research-led teaching institution, with appropriate mentoring from department.
- Teach and assess undergraduate students through classes and coursework (online in 2021/22 and in person thereafter). Facilitate interactive, structured, and highly collaborative classes of 24 students from a range of disciplinary backgrounds (approximately 4 classes per week).
- Work in close collaboration with colleagues to develop materials for one or more thematic streams of the course, including the design of classes and assessment, selection of readings and media-based course content, and creation and delivery of teacher training resources.
- Contribute to the virtual learning environment(s) used on the course by providing relevant materials to support students' learning and collaboration.
- Identify learning needs of students; help to define learning objectives and to provide appropriate support.
- Hold regular office hours for individuals and groups (at least 2 hours per week).
- Provide constructive and actionable formative and summative feedback on both group and individual assessments.
- Participate in regular team meetings with academics and administrators involved in the course.
- Manage academic administration arising from teaching responsibilities e.g. class preparation, recording student class attendance, and writing a short end-of-term report for each student.
- Contribute to development and delivery of LSE100 by leading on specialist projects and initiatives for LSE100 students and staff (e.g. Equality, Diversity and Inclusion, Green Impact, personal and career development sessions, stream-specific events and workshops, etc).
- Participating in activities related to the promotion and communications of LSE100 by, for example, representing LSE100 at events with internal and external stakeholders (e.g., departmental inductions, School open days, and academic conferences).

### **Flexibility**

To deliver services effectively, a degree of flexibility may be required in the duties performed in order to meet the exigencies of service. Job roles may also naturally develop over time and ongoing substantial changes to a role will be discussed between line managers and their staff, with job descriptions updated as and when appropriate.
