



Job Description

This form summarises the purpose of the job and lists its key tasks. The description of the duties and responsibilities reflect the post at the time it was drawn up, the details of which may change over time without changing the general character and purpose of the post or the level of responsibility encompassed.

Job Summary

The Global Surgery Policy Unit (GSPU) is a unique and strategic collaboration between the Royal College of Surgeons of England (RCS) and the London School of Economics and Political Science (LSE). Established to advance global public health, surgical and anaesthesia care, with a particular focus on low and middle-income countries (LMICs), the Unit aims to increase access to safe, affordable, high quality surgery, to improve public health, patient safety and population health outcomes. It will achieve this by:

- Translating original and existing research and the impact of capacity building programmes into high-level public health policy and advocacy initiatives aimed at influencing decision-makers and donors.
- Working with underserved communities, non-governmental organisations ('NGOs'), stakeholders and healthcare workers to empower, inform and improve understanding and practice.
- Fostering the development of global health leaders, influencers and advocates through the provision of training and mentoring in research, surgical systems strengthening, programme evaluation and health economics.
- Creating opportunities and platforms to encourage sustained exchanges of expertise between clinical experts, policymakers, patients, healthcare workers and researchers in the field of global surgery, public health and anaesthesia policy.
- Advocating for greater investment in global surgery and anaesthesia as an important driver in achieving the United Nations Sustainable Development Goals ('SDGs'); improved health outcomes and universal health coverage ('UHC').
- Adopting a multi-sectoral, multidisciplinary approach to its activities and operations by engaging a range of individuals, including academics, clinicians, politicians, lawyers, economists and patients at local, national and international levels.

The Unit will be hosted by the LSE within LSE Health, Department of Health Policy.

The Assistant Professorial Research Fellow will be responsible for developing the intellectual agenda for the Unit in partnership with the Unit's co-directors from the RCS and the LSE. They will ensure outputs and commitments set out in the programme work plan are produced, and will work with Unit partners to shape and identify future analytical priorities for the programme.



Additionally, the post holder will be expected to contribute to the intellectual life of the School through conducting and publishing outstanding quality research and participating in the School and wider LSE Health activities.

A fuller range of responsibilities are outlined below, however the core responsibilities of the role will be to:

- **Lead research into effective policy in the field of global surgery**
 - Conduct substantive and original research on areas relevant to informing global surgical policy, working in collaboration with the RCS and its international membership network.
 - Supervise a research officer/s, and provide support to a number of seconded RCS fellows
 - Publish research outputs of outstanding quality in top academic journals, and where appropriate, other non-academic publications and resources
- **Engage and collaborate with key stakeholders**
 - Develop a network of global surgical policy researchers with the RCS, its international membership network, and wider global surgical research groups
 - Identify the unique contribution of the GSPU within the wider context of the global surgery research community and engage with key global surgical policy stakeholders e.g. research groups, policymakers, think tanks
 - Lead the development of policy briefings, workshops, conferences, and other events/outputs/activities that facilitate knowledge exchange and policy impact
- **Sustain the unit for the long term**
 - Assist in the identification of additional partners, experts, and funders to support the Unit's work beyond the initial three-year investment period

The post holder will be supported in these activities through key relationships within the London School of Economics and the Royal College of Surgeons of England.

This post is currently funded for 3 years in the first instance, but with scope for extension subject to the success of the programme in delivering on its objectives and securing further funding.

Range of Academic Activities and Responsibilities at Assistant Professorial Research Fellow Level at LSE

Research productivity

- Developing and carrying forward a coherent research strategy which will result in public recognition and national and international prominence, and fits within the research agenda of the GSPU project
- Guiding, planning and producing the required policy-relevant research outputs for the GSPU as described in the research strategy and annual work plan, including: working with GSPU partners to identify investigative priorities and research focus areas, writing policy briefs, country monitoring reports, and other comparative analyses that will inform policy in the global surgery space.
- Publishing work of outstanding quality and significance to the discipline in top quality and well recognised international peer-reviewed outlets, including publications relevant to global surgery policy areas
- Conducting substantive and original research into complex problems, ideas, concepts, or theories and applying appropriate methodologies
- Planning and directing significant international research activities and programmes, specifically delivering the GSPU programme



- Leading and/or contributing to peer reviewed funding bids for research programmes in the specialist area and achieving success in attracting such funding, including securing grants to extend and broaden the activities of the GSPU
- Contributing to the development of the centre/institute/department and School research strategy
- Participating in national and international committees if required – e.g. REF panels, Research Funding bodies, etc.
- Contributing to scholarly initiatives in the discipline
- Membership of boards of international journals and other bodies related to the discipline
- Providing expert opinion and commentary to external audiences and bodies
- Providing advice to government bodies

Knowledge engagement and impact

- Planning and delivering engagement, policy dialogues and related knowledge transfer events to communicate research findings
- Evidencing research leadership and expertise through advising or participating in government/international committees, private sector organisations, international bodies, the non-profit sector, or in other governmental or non-governmental organisations
- Actively developing strategies to ensure that research outputs have demonstrable impact and inform the public debate.
- Ensuring that research impact and engagement with wider audiences is at the heart of research strategy within the centre/institute/department, and specifically within the GSPU programme.
- Developing and maintaining expert networks in the global surgery field, with links to other international research hubs
- Expert input into development of executive leadership modules in health policy and economics, with relation to global surgery
- Engaging with non-academic audiences.

Management and leadership of research projects

- Steering the overall intellectual direction of research projects, specifically the GSPU programme
- Attending relevant workshops and policy dialogues
- Leading research projects that may involve co-ordinating the work of others.
- Training and supervising the work of research assistants and of research officers.
- Contributing to the development of teams, through supervision and peer support.

Activities relating to departmental/School management and administration

- Fostering collegiality and fulfilling responsibilities as set out by the Head of Department or Centre/Institute Director.
- Attending and participating in Centre/Department/Institute meetings and contributing towards the intellectual life of the unit.
- Contributing to the development of individuals, through mentoring of junior research staff.
- Support centre/institute/department recruitment activity of research staff, including membership of relevant search committees.

Other responsibilities may include

- Contributing to strategic deliberations and making decisions at Institutional level, e.g. through membership of School committees.
- Supervising Masters' students on projects related to the priorities of the Unit.

Precise duties are subject to the opportunities available, the contractual obligations imposed by the external funding agency and with the agreement of the Co-Directors of the Unit and the Director of LSE Health, in accordance with established line management arrangements and commensurate with the post.

**Flexibility**

To deliver services effectively, a degree of flexibility is needed, and the post holder may be required to perform work not specifically referred to above.
