Job title: Research Officer (Environmental preferences and behaviour)

### Job Summary

The Grantham Research Institute on Climate Change and the Environment, incorporating the Centre for Climate Change Economics and Policy, seeks to appoint a Research Officer to work on the topic of environmental preferences and behaviour. The post is funded through NERC and based within the Grantham Research Institute.

## Duties and Responsibilities

Duties will include the following:

- Conduct literature review on the influence of behaviour on vulnerability to air pollution exposure.
- Design and implement surveys and experiments to elicit individual preferences on air quality, using advanced techniques.
- Contribute to the analysis of the results from surveys and experiments.
- Demonstrate the ability to analyse and research complex ideas, concepts or theories and applying appropriate methodologies
- Write up research for publication in a variety of modes including peer-reviewed journals
- Present research papers at conferences
- Communicate technical results to a wider, often non-specialist audience;
- Contribute to the formulation of peer reviewed research grant proposals
- Contribute creative solutions to research challenges.
- Organise conferences, seminars and workshops.
- Support team members to reach common goals.
- Contribute to the intellectual life of the Institute.

All of the above subject to the contractual obligations imposed by the external funding agency and with the agreement of the supervisor and Institute Directors. The appointee will be expected to play an active intellectual part in the Institute and to collaborate with other programmes within the Grantham Research Institute and the Centre for Climate Change Economics and Policy.

#### Flexibility

To deliver services effectively, a degree of flexibility may be required in the duties performed in order to meet the exigencies of service. Job roles may also naturally develop over time and ongoing substantial changes to a role will be discussed between line managers and their staff, with job descriptions updated as and when appropriate.
