# How to apply and notes for applicants Data Architect - DTS

Your CV should include the following details:

- Employment history (present and previous appointments with dates);
- Education and qualifications (name of awarding institutions and level of qualifications);
- Membership to any professional organisations (if applicable);
- Relevant training courses attended.
