### Job Summary

The successful applicants will be based at the London School of Economics (LSE) and will join a group of LSE researchers under the direction of Camille Landais, Johannes Spinnewijn, Xavier Jaravel and Daniel Reck. The job will entail close collaboration on several new and ongoing projects on a broad range of topics in applied microeconomics with applications to economic policy. Much of the research uses “big data” and quasi-experimental methods to identify causal effects and test the predictions of economic and sociological models. Current projects study for instance the impact of labor market shocks on individuals’ behaviors, the determinants of gender inequality, the price effects of trade and innovation, or the optimal design of social insurance programmes. Interested applicants can consult the faculty members’ websites to learn more about ongoing projects.

The job will include a variety of tasks that provide excellent preparation for graduate school, such as analyzing data, writing and creating presentations, and editing research papers.

### Duties and Responsibilities

- Identifying appropriate methods of investigation or analysis according to data and objectives.
- Conveying complex conceptual ideas or complex information which may be highly detailed, technical or specialist.
- Interpreting and analysing patterns or trends in data.
- Managing large scale databases.
- Conducting literature reviews.
- Assisting in the writing of reports.
- Contributing to the organisation of conferences, seminars and workshops.
- Supporting team members to reach common goals.
- Managing own research and administrative activities, with guidance.
- Demonstrating a knowledge of theory, methods and practice and demonstrating development through acquisition of relevant skills and competencies.
